As members of BFT/Retired we are also members of FEA and NEA. I want to share with you one way Our Unions Are At Work- Advocating for Change.

President Joe Biden recently signed into law the Social Security Fairness Act (H.R. 82). This monumental victory will ensure that millions of educators and other public servants receive the full Social Security benefits they deserve by repealing the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO), which unfairly reduced the Social Security benefits that public employees or their spouses have earned. The National Education Association was at the forefront of advocating for repealing these unjust regulations. NEA members were on hand at the White House to witness history as President Biden signed the law.

Fortunately, FL teachers are not affected by this law; it is a victory for teachers in many states. I recently met a retired teacher from Connecticut that shared her story with me. She had worked in the Public Schools for 30 years and did not pay Social Security. But she had also worked a second job that did take out social security taxes. Because she received a pension when she retired, she was not eligible to receive the Social Security she had paid for from her second job nor was she able to receive her husband's Social Security. She was very grateful that this bill was signed.

It all began with a bulldozer clearing land for a new housing development. It led to an unprecedented wealth of finds from 8000 years ago! The Windover Archaeological Site in Titusville was recognized by the U.S. National Park Service as a National Historic Landmark in 1987. It is also recognized as a Florida Heritage Site. It's one of the most significant archeological sites in the United States, if not the western hemisphere.

The battle to pass the Equal Rights Amendment has been being fought by many since the 1920's. I have personally been involved since the 1960's. For the first time in the 100+ year fight for the ERA, we have a President declaring that the Equal Rights Amendment (ERA) is the law of the land. Recognition of the Equal Rights Amendment as the 28th Amendment to the U.S. Constitution is a victory for all who believe in justice, equality, and fairness.

President Joe Biden declared what we all know to be true: having met all requirements, the ERA is the law of the land. The American Bar Association declared this last August. The Equal Rights Amendment is ours, and we will use it to make this country live up to its promise of justice for all.

Statement from President Joe Biden on the Equal Rights Amendment | The White House:

"I have supported the Equal Rights Amendment for more than 50 years, and I have long been clear that no one should be discriminated against based on their sex. We, as a nation, must affirm and protect women's full equality once and for all.

On January 27, 2020, the Commonwealth of Virginia became the 38th state to ratify the Equal Rights Amendment. The American Bar Association (ABA) has recognized that the Equal Rights Amendment has cleared all necessary hurdles to be formally added to the Constitution as the 28th Amendment. I agree with the ABA and with leading legal constitutional scholars that the Equal Rights Amendment has become part of our Constitution.

It is long past time to recognize the will of the American people. In keeping with my oath and duty to Constitution and country, I affirm what I believe and what three-fourths of the states have ratified: the 28th Amendment is the law of the land, guaranteeing all Americans equal rights and protections under the law regardless of their sex. "

March- In March we'll be going to the Museum of Arts and Sciences (MOAS) in Daytona.

Tripadvisor says it's Central Florida's primary arts, science, and history museum. The Museum consists of a planetarium, art museum that has the largest collection of art from Florida art in the world, a permanent display of Cuban fine art and folk art, African folk art, etc. There's a visiting exhibit of John J. Audubon's "Birds of Florida." Another area has on display fancy railroad cars, including a private coach with all the comforts of home, and a train station. They also have the largest exhibition of Coca Cola memorabilia in the world. The planetarium has 3 shows during the day, one on dinosaurs, one called "The Sky Tonight, Live," and "Wings Over Water" showing the amazing lives of 3 types of water birds.
